## REGISTRATION PROCESS

1. **International Student Application Form** (I will need to know the name of the program you are interested in). Please visit: [http:// studyinthestates.dhs.gov/](http://studyinthestates.dhs.gov/) and the school Website listed above.
2. Color copy of the biographical page of your **PASSPORT** valid for at least six (6) months after the proposed date of entry into the USA. Applicants with dependents must also provide proof of relationship to their spouse and/or children (e.g., marriage and birth certificates) as well as a color copy of their PASSPORT.
3. If English is your second language, **proof of English proficiency** is required. Please read the **TOEFL, IELTS, & PTEA** section requirements: <http://www.ets.org/toefl/> -- <https://www.ielts.org/> -- <http://pearsonpte.com/>.
4. Affidavit of Support (**Affidavit - Room & Board Form, Affidavit-Sponsor Living Abroad Form, Affidavit-Self-Sponsoring Form, and/or I-34 (Declaration of Financial Support)**).
  - a. Copy of Financial Evidence showing that you or your sponsor has sufficient funds to cover tuition and living expenses during the period of your program. If the student has dependents (spouse/child), an additional \$2,500.00 (USD) per dependent is required (letter should be printed on bank's letterhead and also contain the signature & seal of Notary Public. Letter cannot be more than one (1) month old):
  - b. **The banks statements:** Three (3) most recent bank statements showing available balance and account holder information for each account intended to use. All funds must be in US dollars. All documents must be in English or include an official notarized translation.
5. If the student or sponsor is a salaried employee, the applicant should bring income tax documents, original bank records and statements. A letter from the employer on official letterhead with 1) the name of the employee 2) the annual salary 3) the dates of employment.
6. If the student or sponsor owns a business, the applicant should bring business registration, licenses, etc., and tax documents, as well as original bank records and statements.
  - a. **You may have one (1) sponsor, more than one (1), or be your own sponsor.**
7. Copy of **transcripts, High School Diploma, or diplomas** from previous institutions attended (Students are responsible for obtaining their own translation and evaluation which may be completed by selected outside agencies approved by the School Board of Broward County, Florida. **NOTE** that just a translation of the foreign transcript is not sufficient; the educational records must be certified "as being the equivalent to a secondary and/or postsecondary education in the United States."
8. **If admission and financial requirements are met I will create and INITIAL SEVIS record and issue a Form I-20.**
9. The student pays **SEVIS fee** (\$350.00). <http://www.fmjfee.com>.
10. International students will be eligible to apply for the M-1 student visa interview at Consulate or Embassy, or USCIS for a change of status. <http://usembassy.state.gov/> or <http://www.uscis.gov/>.
